situations. We will also examine the new IR35 rules which came into force on 6 April 2021, and their impact on cross-border working arrangements when engaging contractors via personal service companies.

Brynmawr Foundation School v Holiday World International Travel Limited (t/a Leisure World Schools) (Cardiff County Court: Trial 7 December 2021, Judgment handed down 2 February 2022)

Following the announcements in March 2020 by the UK and devolved Governments advising against school trips outside of the UK because of the COVID-19 pandemic, many schools in the UK terminated their contracts with tour operators. A number of travel companies have argued, for a variety of reasons, that the Package Travel and Linked Travel Regulations 2018 ("the PTR") do not apply to such terminations. This is one of the first cases dealing with such issues to reach the English and Welsh Courts....[Read More]
